

Dear Pastor,

God has given me a burden to assist church planters in reaching the people of the Ivory Coast, West Africa, with the gospel of Jesus Christ.

Many years ago, Missionary Bob Mach shared a video about ways that people could use their skills to assist in church planting on the mission field. One of the ways that he shared was English as a Second Language. In his testimony after the video, he said that he is regularly asked by the people of the city when he will start an English school and that the door is wide open for using teaching English to share the gospel and reach more people in the community.

When I knew that God was leading me to go to the mission field, He brought to mind that video. Last summer, I took a survey trip with the purpose of discovering how God might allow me to use my teaching skills to open doors in sharing the gospel.

During that trip, I was able to tutor kids from the local public school, develop a relationship with them, share my beliefs with them, and invite them to church. I was also able to teach in a private school and, in the process, share my own beliefs. If I were to return, I could start a Bible club in that private school and have the opportunity to reach even more students with the gospel.

One of the primary objectives of my trip was to see whether we could start an English club at the Felix Houphouet-Boigny University (the largest university in the Ivory Coast) for the ultimate purpose of sharing the gospel. We were able to meet with the dean of the English department, and he is a Christian! He was ready to set me up right then and there with a classroom.

The door is wide open! While the people see learning English as a means of getting better jobs and improving their quality of life, I know that teaching English allows me the opportunity to show them that Jesus is the Way, the Truth, and the Life, and that the best life is a life given to Him!

Would you consider partnering with me in reaching the people of the Ivory Coast? I would love to be able to visit your church and share the vision that God has given me.

Laccepted Christ as my Saviour at a very young age. Looking back, I believe He had me stay so that I might deepen my relationship with Him, develop my skills as a teacher, and grow as a person.

Then about a year and a half ago, the Lord really began working in my heart, showing me that it was time. He was fulfilling the desire of my heart. In March 2021, I met with my pastor, Pete Folger, and shared with him what God was doing in my heart.

I then started praying about exactly where the Lord would have me, and over time I became sure that He was leading me to the Ivory Coast to work alongside veteran missionaries, Bob and Becky Mach. As of right now, I plan to teach English in local schools and the university to open doors to sharing the gospel with people who might otherwise never hear about Christ. I also plan to assist Bro. Mach in teaching in the Fundamental Baptist Bible College.

The rest of Psalm 16:11 says, "in thy presence is fulness of joy; at thy right hand are pleasures for evermore."

Truly, the place of greatest peace and joy and satisfaction is found in pursuing the path that God places before us. I look forward to this next step that He has laid before me.

The country has been essentially divided between Muslim north and multi-faith but predominantly Christian south. Although peace is established and the nation is moving forward, the loss of life, of infrastructure and of confidence in Côte d'Ivoire's fundamental unity will leave scars on the nation's psyche.

Animism is still strong in Côte d'Ivoire, despite apparent numerical decline. Although evangelical congregations outnumber sacred fetish groves for the first time in the nation's history, animism's power remains unbroken and penetrates deep into the worldview and practices of both Christians and Muslims. Many believers are affected by the power of African traditional religion, especially through fetish charms and ancestor worship, compromising both their witness and their own life in Christ.

Islam spread and grew rapidly during the 20th Century, from 5% in 1900 to near 41.8% today. Tribal groups in the north and pockets of tribes all over the country are becoming Muslim. Urban concentrations of Muslims are high as are conversion rates among new immigrants to the cities.

Abidjan's exploding population has doubled in the last 15 years to five million in the metropolitan area, making it the third largest city in the Francophone world. It is the strategic key for evangelization of Côte d'Ivoire, Mali and Burkina Faso. All people groups of these latter two lands have a significant community in the city, but most are neglected by the Church. Over 2.5 million Muslims, roughly half of the city, are scarcely touched with the gospel.

Young people are responsive, and wherever churches minister specifically to them, there is fruit. Liberty to teach Scripture in public schools is an exciting but under-used opportunity through lack of qualified personnel.

# Statement of Faith

#### **The Bible**

I believe that the Bible is the verbally inspired Word of God. I believe that He used men to pen those words under the inspiration of the Holy Spirit. I believe He came to earth as the son of the Virgin Mary, lived a sinless life, and offered Himself on the cross as a substitutionary sacrifice for the sins of all mankind. I believe that His death on the cross is the only way to an eternal heaven. I believe He resurrected bodily and ascended into Heaven where He now resides until His return. (Isaiah 7:14, 9:6, 43:11; John 1:1, 3, 14, 18, 29; Romans 3:19–25; Romans 5:6–15; Philippians 2:5–11; 1 Thessalonians 4:13–18; 1 Timothy 2:5, 3:16; Titus 2:10–15; Hebrews 7:26, 9:24–28; 1 Peter 1:19, 2:2; 1 John 1:3; Revelation 20:1–6)

#### The Holy Spirit

I believe the Holy Spirit of God is an equal person of the Godhead who is presently indwelling and directing those who are saved along with advancing the gospel in the world. The Holy Spirit is sent to regenerate, sanctify, seal, and indwell all who have placed their faith in Jesus Christ. (Genesis 1:2; Matt. 28:19; John 3:5–6, 14:16; Acts 1:5, 11:15; 1 Corinthians 3:16, 6:19–20; 1 Corinthians 12:13)

#### Sin and Salvation

I believe all men were born with an inherited sin nature received from our common ancestor, Adam. I believe that because of his nature, man is a sinner by choice, and he is totally incapable of reforming himself or ceasing from his sin by his own power. I believe the only hope of deliverance for man is a total change of mind concerning his sinful condition and inability to change it, and a turning to Jesus Christ as the only Savior. I believe that only through the substitutionary sacrifice of Christ on the cross can a man be delivered from his sin. I believe that all those who reject Jesus Christ as their Savior are already condemned to an eternity in the lake of fire. (Genesis 5:1-5; Acts 4:19; Acts 16:31; Romans 3:10-23; Romans 5:6-12; Romans 6:23; Romans 10:9-10; Ephesians 2:8-9; Titus 3:5-6; Revelation 20:11-14)

#### The New Testament Church

I believe the local church is Christ's institution for advancing His gospel and doing His work in the world. The church is made up of those who have been saved and biblically baptized (Acts 2:4; Col. 2:13; Matt. 3:13-17) uniting and faithfully gathering together for the purposes of Bible teaching, worship, prayer, fellowship, service, and observance of baptism and communion. This body is autonomous in nature. (Col. 1:18; 2nd Cor. 8:1-8; Matthew 16:16–18; Acts 1:15, 2:41–43, 11:15, 20:28; 1 Corinthians 15: 51–58; Ephesians 1:12–14, 5:25–30; 1 Thessalonians 4:13–18; 1 Timothy 3:4–15)

#### Separation

I believe that a Christian should grow in grace, living a life that is becoming of the gospel and honoring to Jesus Christ—properly reflecting His love and holiness. I believe in separating from biblical heresy and from sinful, self-destructive, and immoral behavior. (Romans 12:1–2, 14:13; 2 Corinthians 6:14–7:1; 2 Timothy 3:1–5; 1 John 2:15–17; 2 John 9–11; Leviticus 19:28; 1 Corinthians 6:19–20)


#### **End Times**

I believe in the literal interpretation of the Scriptures in context and with a dispensational view of prophecy. I believe that following timeline of future events will go as follows: first, the rapture of the church, followed by a seven-year tribulation and the return of Jesus to the earth, followed by His literal rule of one thousand years ending with the Great White Throne Judgment, culminating with the creation of a new Heaven and new earth. Dear Prospective Supporting Pastor,

It is with much confidence that I recommend Kristina Premo to you for consideration as an addition to your missions program. We have been blessed to know Kristina since 2010 at which time she joined our home church, the Cleveland Baptist Church. She came to Cleveland upon completing her college degree program to teach English in our Christian school.
